What can we say about this time? This is a question I ask every week as I prepare our service and message. What can we say about this time looked at through the lens of the scriptures for the week, looked at through the lens of the founding beliefs of the Lutheran and Reformed Church, through the lens of Christ's Greatest Commandment: *Love thy Lord, thy God ... and love thy neighbor as thyself*.

The other question we have had to ask during this time is how are we going to say these things? How are we going to continue to be the church, to do the work of the church, to be the body of Christ - the feet, hands and voice of Christ when we were not allowed to go out, to touch and only to speak behind masks? Keeping the spirit of the church vibrant and well from Palm Sunday to Trinity Sunday, maintaining fellowship and Christian nurture even when we can not be together in the church building, has been our challenge.

First we offered curbside church with a short individualized mini service of greeting, prayer, music and blessing. Then radio church with a team of readers, speakers and musicians from here and far away contributing to a professionally recorded and produced 1/2 hour program of worship. Throughout this time we had a team of bell ringers proclaiming the presence of the church every Sunday and the Council members as 'Good Shepherds' checking in with congregants to chat, keep in touch and hear their need for prayer.

Now since June 7 we are again holding worship in the Sanctuary with thorough safety precautions in place and an exemplary, though necessarily different, way to take communion which we will continue to celebrate every first Sunday and feast days as we see where guidelines take us. We have been working on how to replicate as best as possible the 'radio worship' experience for those who are unable or choose to not attend these services. We have had a couple of trial runs with recording in the sanctuary which did not produce the good sound we were hoping for, but are leading us in a good direction for making worship available by internet, CD or phone.

Everyone, including the Holy Spirit, has been working overtime these last few months. God has presented us with unforeseen challenges, with new ways to offer praise, respond to his grace, take stock of our lives, and embrace our neighbors. Let us continue to participate in worship, attend to the Word, reach out to others and pray for the world.

This prayer for our 'Human Family' in the green LBW hymnal (pg 44) is a good one.



Council members present Pastor Ela, Michelle Harshbarger, Sue Lynch, Ed Bilich, John Boring, Carol Fultz, Denise Chester, Joy Byler, Nancy Penepacker, Deb French and Jami Zook.

President Fultz called the meeting to order. Pastor Ela led us with devotions and prayer.

Approval of Minutes - April minutes were presented, with a motion to accept the minutes with the following changes; Kelley Maguire's last name to be added concerning the completion of the audit and deleting a sentence in old business regarding hiring a full time organist. Motion was made by Ed Bilich and second by Sue Lynch. Motion carried.

Financial Report – St. John's financial report was presented. Motion to approve was made by Joy Byler and second by Deb French. Motion carried.

St. John's Day Care financial report was presented. Motion to approve by Jami Zook and second by Nancy Penepacker. Motion carried.

COMMITTEE REPORTS

Day Care

Discussion was heard on St John's Day Care reopen in yellow or wait until green restrictions/ guidelines are in place. There are numerous recommendations (not requirements) that come into play if opening in yellow. Currently, a "sign in" area was suggested at the door by the restrooms, with a registration book to sign, hand sanitizer and masks available for all who enter. All people will exit thru the door by the narthex/coat rack area.

Wall was removed to enlarge Pre-K Counts room. This was entirely paid by the Pre-K Program. Painting and cleaning will be done prior to reopening day care. This work to be on Monday's and Fridays. New flooring will need to be installed but this will be discussed at a later date.

An electric heater needs replaced in the room by the elevator. A motion was made by Jami Zook that the property committee repair or replace the electric heater, spending up to \$500. if needed, motion second by Joy Byler. Motion carried.

Discussion was heard on having the parking lot repaved while the Day Care is closed. Although this would be the perfect time, we are still short on funds. Looking over our existing accounts; the youth account has not been used for many years and neither has the Randolph and Kester investments. The Wellsley account could also be an option.

Gladys Mahady Trust funds would not be available till after September 2020, generously leaving St. John's 35% of her remaining estate. A motion was made by Ed Bilich that we speak to the Randolph and K<ester families about the stipulations of their donations and if it would be possible to use some, or all of this money toward repairing the parking lot. Jami Zook seconded the motion. Motion carried. Jami Zook has agreed to talk to Glen Randolph and Denise Chester will speak to Bill and Charlie Kester. Michelle Harshbarger agreed to see if some of the Pre-K Counts monies could also be used for the parking lot repairs.

CYBER BUSINESS

A motion was made by Ed Bilich, and seconded by Jami Zook to extend the radio broadcast for another 4 weeks. (Our broadcasts were to end on May 3. The extension would run to May 31.) Motion had carried. This business was done via email prior to our May 14th meeting.

However, Pastor Ela tells us this evening, that the broadcasts could be extended weekly. These productions have become very time consuming for her and Bill. She suggested maybe parking lot preaching instead. To start parking lot preaching at this time would require too much planning/changes to have for a possible week or two. To continue with the radio services, discussion was heard on shortening the broadcast services, making it less time consuming and easier to produce. Council is hopeful that we can start meeting in the church again the beginning of June, with procedure changes. No action was taken.

OLD BUSINESS

Synod Assembly canceled indefinitely.

John Haubrick will be available to play organ for us (3rd, 4th and 5th Sundays) until June 2021.

Council retreat and inviting Craig Miller/Jim Bricker to St. John's are tabled at this time.

Website is a work in progress. The home page is up and running. We hope to attach the monthly Newsletter, weekly bulletins, and Day Care updates. The current, simplified financial statement will be included in the bulletins. A motion was made by Sue Lynch to attach the Council minutes to the monthly Newsletter. Motion seconded by Michelle Harshbarger. Motion carried.

NEW BUSINESS

Someone has been using our dumpster. Jami Zook made a motion to put a lock on the dumpster; it was second by Deb French. Motion carried.

Kelly Byler suggested that we think about filling the oil tank while prices were down. Ed Bilich made a motion to fill the oil tank. It was second by Joy Byler. Motion carried.

Next meeting is June 11, 2020, 6:30 pm. Having no further business, a motion to adjourn was made by Jami Zook and second Nancy Penepacker. Meeting ended with the Lord's Prayer.

CYBER BUSINESS ~ 5/19/2020

A motion was made by Joy Byler to reopen St. John's Day Care as of June 1. This comes after a Day Care meeting outlying safety precautions and procedures. Jami seconded the motion. Motion carried

8/28/19 Council Meeting

Emergency Fund (for emergency church expenses / issues) – was discussed. Joy Byler made a motion to use the interest from the Thrivent Investments to start an "Emergency Fund" that could not be touched without Council approval and Congregational notification. Carol Fultz second the motion. Motion carried The logic behind the creation of this fund was:

Chapter 12 – C12.05.c – of the SJ Constitution states, "The Congrigation council may enter into contracts of up to \$2,500 for items not included in the budget.

An emergency payment of more than \$2,500 – ex: furnace repair – would need the approval from the congregation before the council could legally move forward with the repair

Church congregational meetings require a 2 week notice before a meeting

The fund was created to allow timely response to a "church emergency"

No disbursements from this fund are to occur without council approval

Discretionary Fund

As the name of the fund indicates, disbursements from this fund are at the discretion of the fund manager (the pastor).

The pastor manages the fund

Money is used to help the recipient with a known or perceived financial need

Checks issued from the fund are signed by the pastor and a second designated person as a "check and balance" on the disbursements

Names of the recipients are kept confidential

Documentation regarding disbursements are kept on file in the church office
