The Property Committee will be discussing upcoming projects which require congregation approval.


As promised, council will be reviewing the results of the questionnaire which was sent out last fall.

# St. John's COVID In-Person Worship ~ Precautions and Safety Measures (updated January 2021)

- 1. Church will be cleaned thoroughly and sprayed with disinfectant following each service.
- 2. For worship services, members are asked to please enter through the front doors of the church **only**.
- 3. Masks are to be worn. Disposable masks are available in the narthex. All other entrances to the church will remain locked.
- 4. A greeter(s) will be there with a mask and gloves on. A bulletin will be either handed to you/laid on the table. Disposable gloves are available on the old altar for use by the greeter(s) and elevator operator.
- 5. Members and visitors are asked to use the steps to the right (Belleville side) to enter the sanctuary, and exit using the stairs to the left (Mechanic St. side).
- 6. Please sit 6 feet apart from one another, unless you are a family living in the same household, remembering to leave at least one or more pew(s) between you and others.
- 7. The entire service is printed in the bulletin, including the hymns.
- 8. Anyone attending is asked to please leave your mask on for the entire service.
- 9. Offering plates can be found on the front and back pews on the (Mechanic St. side). You may place your offering in one of them following the service.
- 10. Volunteers operating the elevator will be required to wear a mask and gloves.
- 11. Communion ~ for the time being, we will be using the juice and wafer cups. The greeter will hand one to you the Sundays we celebrate Holy Communion. Trash cans have been placed in the back pew by the offering plate and in the narthex. Please use these for your empty communion cups, bulletins and any other items you wish to dispose of.
- 12. Anyone wearing a coat, can either take it upstairs with them, or hang it in the coatroom.
- 13. Newsletters and other information is once again being placed in member mailboxes. Anyone preferring to have their items mailed are asked to please contact the church office or your good shepherd.
- 14. Hand sanitizer can be found in the narthex, on the sanctuary windowsills and throughout the church.

Until further notice, there will be no Sunday school, Social Hour or gatherings of any kind, with the exception of council and committee meetings.

These restrictions are in place for the safety all. The council would like to thank everyone for your continued cooperation and willingness to attend worship as we look forward to the day when we can come together again, without the need for these precautions and measures. Due to confidentiality issues, we ask that you <u>PLEASE be sure to have permission</u> from the person/family you are requesting prayer for.


Pray Always. Do not lose heart. Persistence in our every encounter with the divine will be blessed.


They will be available in the narthex on Sunday, January 31. Please contact the church office or your good shepherd if you would like to have one mailed to you.



## Daycare News

After reopening in June, the daycare was blessed to have no COVID cases among the staff until December. At that time the center was closed for thorough cleaning and quarantine per PA Department of Health guidelines for all child-care facilities. After re-opening just before Christmas, two weeks later another staff member tested positive and we had to close once again. But, in the midst of these challenging and uncertain times we continue to be blessed, as the families of our children have been extremely understanding and supportive. When the fears and frustrations that surround COVID surround us, we look to the powerful words of Psalm 91, placing our trust in God's promises, and pray protection over the children He has placed in our care.

Below and on the next page are three pictures. The first is the inspiring bulletin board found at the bottom of the basement stairs. Anita Hostetler, who works part-time as a teacher's aide used over 150 pages of hymns taken from an old hymnal, to cover the board. It is a reminder that this is not just a daycare, but a Christian daycare, where the teachers and staff provide a foundation for each child's faith, teaching them about the Bible, through word, song and prayer. The second and third come from the bulletin board in the infant room, done by teacher, Lisa Colpetzer. Each month she showcases the babies in her room in creative and entertaining ways. We are always anxious to see what she has planned next. Look close, and you may recognize something familiar about the little fellow beside the Christmas tree and on the sled at the top of the hill. He is William "Liam" Kauffman, son of Sabrina (Boring) and Ben Kauffman.

## Nov. 12, 2020

Our mission statement

<u>Council members present</u> - Pastor Ela, Ed Bilich, John Boring, Carol Fultz, Denise Chester, Michelle Harshbarger, Joy Byler, and Jami Zook.

President Fultz called the meeting to order. Pastor Ela led us with prayer. This was a virtual meeting

<u>Approval of Minutes</u> - Motion was made to accept the Oct. 08, 2020 council minutes with the correction, Joy Byler did not lead a CPR class for the Day Care. That line will be strickened from the October minutes. Motion was made by Ed Bilich and second by John Boring. Motion carried.

#### **Financial Report -**

St John's financial report was presented by Ed Bilich. Motion to approve was made by Jami Zook and second by John Boring. Motion carried.

St. John's Day Care financial report was presented. Motion to approve by Michelle Harshbarger and second by Joy Byler. Motion carried.

#### Proposed 2021 Budgets -

Discussion was heard on the 2021 proposed budget. Changes; increase to include the proposed organist salary and Music and Worship committee expenses being increased to \$800. Motion to approved proposed budget was made by Michelle Harshbarger and second by Jami Zook. Motion carried.

Pastor Ela mentioned that with the generous donation by Gladys Mahady we should consider putting a line item in our budget for Outreach ministries. In recent years we have not had the

funds to contribute to a greater mission ouside of our church. Michelle and Mike Harshbarger also had the same thoughts and suggested half the interest earned from the Mahady funds once invested. This was tabled until the Finance Committee has a chance to come back to the council with their recommendation for investment etc.

The proposed budget for St. John's Day Care was presented. Motion to approve proposed budget was made by Joy Byler and second by Denise Chester. Motion carried.

#### **Old Business-**

Pastor Ela reviewed with council the organist's contract that will be extended to Susie Yoo for approval. There are several revisions to be made, fees for weddings and funerals, and clearances verified. Pastor Ela, and the Music and Worship committee recommend \$10400. annualy with 2 weeks paid vacation. Joy Byler made a motion to accept the contract and Denise Chester second. Motion carried.

#### **New Business-**

President Fultz suggested we have a sign in front of the church welcoming people to join our parking lot services. Pastor Ela thought we could also offer bulletins and communion. We would have them park out back in order to see how many are there and cut down on the traffic noise. A motion was made by Michelle Harshbarger for Ed Bilich to purchase signs at Kish Printing, spending \$100. or less. Joy Byler second the motion. Motion carried

Pastor Ela reported that the Synod is allowing leniency for all church related meetings, voting and so forth due to COVID. After discussion, John Boring made a motion to hold our December 13th congregational meeting but to hold off on voting untill the Feb. 14th 2021 meeting. Joy Byler second the motion. Motion carried.

It was suggested we have a back up plan for our Christmas Eve service. Michelle Harshbarger suggested that we hold the service in the parking lot, have a shorter service with caroling in the parking lot. Council will meet Sunday Dec 6th, after church, to make a decision. Also, it was decided that we have the church order 24 poinsettias, then offer them to members for a donation. Those that don't sell, we can distribute to shut ins. No decision was made on ordering gift bags for the children that may attend the service.

The question was then asked if we should shut the church down. It was decided that we can safely social distance, and other precautionary measures have been working well. Those

members that do not feel comfortable in the sanctuary can join us from the parking lot. Starting this Sunday we will ask members to wear masks throughout the entire service.

The 2021 volunteer schedules will be printed monthly in the Newsletter, rather than yearly, due to the small amount of members attending services. Please consider serving if you are not already.

There was an unanimous motion to end the meeting. All second the motion. Motion carried.

#### Minutes of the December 10, 2020 Council Meeting

#### **Our Mission Statement**

We, the members of the St. John's congregation, promise to share the good news of Jesus Christ and love one another through worship and service in our homes, church, community, and the world.

St. John's church council met on Thursday, December 10, 2020 in the sanctuary of the church (due to COVID social distancing). Present were: Pastor Ela Robertson, President Carol Fultz, Ed Bilich, John Boring, Deb French, Sue Lynch, Joy Byler, Michelle Harshbarger. Absent were Jami Zook & Denise Chester.

The meeting was called to order. Pastor Ela provided devotions and prayer. The minutes were presented from the November 12, 2020 ZOOM meeting. A motion to accept the minutes was made by Sue Lynch and seconded by Michelle Harshbarger. Motion carried.

The Financial report was presented by Ed Bilich, Treasurer. Ed pointed out a few items of importance. A motion to accept the church financial report was made by John Boring and seconded by Deb French. Motion carried.

The Daycare financial report was presented by Ed Bilich, Treasurer. A motion to accept the financial report for the daycare was made by Michelle Harshbarger and seconded by Sue Lynch. Motion carried.

Pastor's report – Pastor Ela had her report typed out and gave everyone a copy. You will find this report as a separate attachment to the minutes. In addition to the report provided, Pastor Ela elaborated on the possible radio service option (if it comes to that again), that the radio station is offering it at \$300 per month, which is \$100 less than before. Pastor Ela also mentioned the Discretionary Fund and asked if there was anyone who would benefit from help from this fund, and to let her know if there is anyone in need.

#### **Committee Reports:**

Cemetery, Long Range, Property, and Christian Ed Committees had no reports.

**Music and Worship** - Worked on Susie Yoo's contract and will have it for Susie on Sunday (12/13/20). Pastor Ela is encouraging Reba Harmon to help lead worship while doing parking lot service, as she does a great job. Also, Pastor Ela is requesting people to suggest their favorite Christmas carols.

**Day Care** – the day care committee met on 12/9/20. Lisa Lingle (the day care director) requested a meeting concerning some of the parents taking their children out of daycare temporarily for various reasons and wanting their spots to be held. It is in the contract that you must pay the full amount of tuition even if they can't come at times for various reasons. Now that the pandemic is among us, there are parents who may be layed off at work and can be home with their children, but want their spot held and can't afford the full tuition. It was decided that we would charge a base rate of \$200 for one child and if there are any other siblings it would be an additional \$50 per sibling until January 13<sup>th</sup> (when school is to reopen from the COVID shut down). When it gets closer time, we will re-evaluate this in the event school doesn't reopen. While in the daycare meeting on 12/9, the daycare directer was contacted that one of the employees is COVID positive, and there are already a few other employees who were off due to exposure. It was then decided that we cannot effectively run the daycare with the shortage of teachers, so we made the decision to close the daycare until 12/21/20 and employees that haven't already been tested, will be tested for COVID. The week of 12/14 the employees that tested negative will then go in and sanitize the center. There are NO children at the center with COVID to date.

**Finance** – Ed Bilich, Treasurer, discussed the Mahady bequest. The finance committee is working on placing the Mahady moneys in various investments, checking accounts, etc. and will be finalizing this very soon. Also, Ed has been looking in to the telephone/internet bills and trying to find ways to save money and get a better internet package. A motion was made by John Boring and seconded by Joy Byler to give Ed permission to make the decision on a good package. Motion carried.

#### Old Business -

Services: It was decided to have only parking lot services through the end of the year due to the rising COVID counts. We will then re-visit this and decide where to go at that point.

We still need at least one name for the new 2021 church council in order to meet the minimum requirements.

Carol Fultz thanked Ed Bilich for heading up the signs for the parking lot service. It's much appreciated.

Pastor Ela would still like to continue looking into making policies for COVID and church safety.

#### New Business -

The 2021 church calendars and offering envelopes will be ready next week. It was discussed how to get these to members, since they normally come to church for them. It was decided that the shepherds would deliver them to their shepherd list.

There was discussion on the Christmas Eve offering. The Siennick family from Juniata County, is a family who had a tragedy in January of this year, when the mother of six children was in bed, and her then boyfriend stabbed her to death, leaving behind 6 children. Juniata Valley Bank has an account set up for this family. Michelle Harshbarger made a motion and Sue Lynch seconded the motion to direct the Christmas Eve offering for this family.

Carol asked about altar flowers during our parking lot services. Do we want to cancel our altar flowers during parking lot service, as long as we contact the people who have signed up for them to make sure it's ok with them? It was decided to go forward and cancel them after contacting the people each week.

There was a discussion of the Christmas Eve service and how we may want to approach it this year since it will be in the parking lot.

With there being no further business, the meeting was properly adjourned. The next monthly meeting of church council will be Thursday, January 14, 2021.
