As I sit down to write on this date, 2/22/2022, I am reminded of two things: 1) The power of partnership and how much is accomplished when we work two by two. Whether it is two people stirring a soup kettle for Meals on Wheels or Souper Bowl Sunday, or a couple married for over 30 - 70 years dedicating their lives to Christ's mission and justice in the world in small ways, or the church partnering with community agencies to bring disaster relief and spiritual nurturance. Partnering with each other, two by two is what we're called to do. 2) The number 22, twice 11, is also often associated with the first eleven 'faithful' disciples. We learn so much in scripture from their questions, their doubts, their fears, their willingness, their endeavors and their faith. Yet, we are also reminded of the 12th, the Judas, going behind the backs of others in his own self interest and we question whether we would act his part or be of the 11. The generating power of these disciples' struggles and sacrifices, 11 multiplied by 2 and 2 and 2 again has created the potential of the church today even as we relive their errors and doubts.

February here has been a month of frigid ice storms, 35 mile an hour winds that whiz by in one direction and then suddenly, inexplicably, turn forces the other direction stirring up dead leaves in their wake, yet uncovering sleeping daffodils, new growth shooting up through the snow. It is a month set aside to honor the legacy of both St. Valentines and Martin Luther King, Christ's love celebrated in chocolate and cards and the more challenging call to justice.

In the church year we approach Transfiguration of the Lord, the unveiling of the glory of God in Christ, the pivot point between Epiphany and Lent. Both Paul's letters and Christ's words to the disciples at this point in our lectionary often seem harsh and impatient. But are they harsh and impatient or isn't this just urgency? No matter how many thousands of years it takes there is always an urgency for each individual in their short flash of history to respond to the Church's <u>ultimate</u> purpose. There is always an urgency to keep this 'ultimate' purpose in mind. And what is this ultimate purpose? It is again to accomplish a world here as it is in heaven, where God's will is done, where Christ's mercy to us is experienced in tears and joy, where tenderness is not reserved for some and not for others, where even in the urgency of God's ultimate purpose we can slow down, pay attention to detail, listen, be open to God's call, be open to each other, forgive, mend and foster disciple relationships in love.

Let us live God's grace and gifts. *Pastor Ela* Rev. Ela J. Robertson


Take a seat...

If you would like to place an arrangement beside the lectern in memory or honor of a loved one during this time, please contact the church office.






